#### **Three Schemes to Ensure Social Security**

#### PM Suraksha Bima Yojana (PMSBY)

- · To cover accidental death risks.
- Cover of ₹ 2 Lakh for a premium of just ₹ 12 per year.
- 9.43 Crore Policies enrolled.

#### PM Jeevan Jyoti Bima Yojana (PMJJBY)

- · Covers natural and accidental death risks.
- Cover of ₹ 2 Lakhs to any Savings Bank holders in the age group of 18-50 years for a premium of just ₹ 330/- per year.
- 2.96 Crore policies are enrolled.

#### Atal Pension Yojana (APY)

- Defined pension Scheme for Unorganized Sector.
- Government contributes 50% of beneficiary premium (upto ₹ 1000) for 5 years to those who joined the scheme before 31.3.2016.
- More than 26 Lakh subscribers already.

#### Rural

- 1.92 Crore toilets have been constructed in 2014-16.
- Incentive for individual toilet has been increased to ₹ 12,000.
- 14 Districts, 190 Blocks, 23790 Gram Panchayats and 56206 Villages have declared themselves as Open Defecation Free (ODF).

#### Urban

- 15.10 Lakh individual household toilets completed.
   76,813 Community and Public Toilet seats also completed.
- 400 cities to be made 'Open Defecation Free' by December, 2016.

# Solving Long Pending Issues

#### Land Boundary Agreement with Bangladesh implemented-Pending for 4 decades

- · Enclaves transferred between the countries.
- Ends uncertainty over nationality of 51,000 people in 162 enclaves.

#### No More Villages in Dark

18,000 villages without electricity even after 67 years of independence to be electrified in 1000 days

- 7779 Villages already electrified.
- GARV- (Grameen
   Vidyutheekaran) mobile
   app for citizens to monitor rural electrification.



### -1 Rank-Pension

#### No More Worries on OROP

- 'One Rank One Pension' a demand pending for 4 decades notified.
- Pension refixed on basis of average of minimum and maximum pension of personnel retiring in 2013 in the same rank and with the same length of service.
- Arrears to be paid in four equal half yearly instalments, in single instalment for family pensioners and Gallantry award winners.
- · Pension would be re-fixed every 5 years.

#### No more free reign for Black Money-Decisive multi-pronged action

- Special Investigation Team constituted, chaired by ex-Supreme Court Judge.
- A new Black Money Act enacted with strict penalty provisions.
- Many recommendations of SIT been implemented.
- Decades-long loophole of Mauritius tax treaty ended through successful re-negotiation – will prevent 'roundtripping' & treaty abuse.
- All transactions above ₹ 2 Lakh require PAN.
- · Tax collection at source for costly cars to establish trail.
- A new Income Disclosure Scheme formulated for domestic black money.
- Enhanced enforcement measures resulted in unearthing of tax evasion of approximately ₹ 50,000 Crore of indirect taxes and undisclosed income of ₹ 21,000 Crore. The value of goods seized on account of smuggling activities has increased to ₹ 3,963 Crore in the last two years.
- · Prosecution launched in 1466 cases.



#### No More Schools without Toilet More than 4 Lakh toilets constructed



- 100% target achieved for Swachh Bharat Swachh Vidyalaya Campaign within one year.
- 4,17,796 toilets added to 2,61,400 government elementary and secondary schools by August 15th, 2015.
- Provided separate toilets for girls and boys in all schools.

- The First set of 100 declassified files released on Netaji's 119th Birth Anniversary on 23rd January 2016.
